A) EVENT REGISTRATION

REGISTRATIONS FOR INDIVIDUAL SCHEDULED RACES

All entries must **imperatively** be received by Formula Imola Spa by **Monday 02nd September 2024 time 12.00** and must be accompanied by the appropriate entry fees.

The registration procedures for the events included in the ACI Racing Weekend 2024 are partially modified as follows:

Registration must take place as follows:

Competitors with an Italian license through the online "pre-registration" procedure on the ACI Sport website
ID Gara **24147** for modern car ID **24103** for Historic car.

Information on how to use this procedure can be found on the Aci Sport website.

Please note that pre-registrations, once accepted by the organizer, will no longer be visible or modifiable by the competitor.

N.B. A competitor with an Italian license can enter drivers with a foreign license in the race.

This procedure is MANDATORY for all Italian competitors and to it must be added the registration on the new "Circuitenter" portal which can be reached at the following link <https://circuitenter.it>

All competitors (with both an Italian license and a license from another Federation) must therefore MANDATORY register via the Circuitenter portal which can be reached at the following link <https://circuitenter.it>

To register it is necessary to register and create the profiles of the competitor, drivers, team, car and invoicing in the personal area, if not already done on the occasion of previous ACI Racing WE events,

Access the "Registrations" area to send registrations by selecting the profiles created, enter the mandatory payment account and add the required details.

By sending the registration, an automatic notification email will be generated and a summary of the forms to be prepared in view of the event.

Upon receipt of payment as indicated in the summary, a second notification email will be sent to confirm completion of registration.

Please remember that registrations will not be accepted unless accompanied by the registration fee, to be paid by registered bank transfer.

Free practice sessions **MUST BE MANDATORY PAID** by bank transfer to the same bank account provided above for the entries and together with them and uploaded to the Circuitenter portal within the established deadlines.

The release of liability (Annex 1) **MUST NOT BE SENT BY EMAIL NOR UPLOADED ON THE CIRCUITENTER PORTAL** but duly signed in original it must be delivered as follows:

from 15.00 to 19.00 on 05 September 2024 and from 08.00 am to 12.30 and from 14.00 am to 18.00 on 06 September 2024 on the second floor of the Race Direction Building (Office 1).

FOR FREE PRACTICES, A STICKER WILL BE DELIVERED TO BE APPLIED TO THE CAR (WINDSHIELD TOP LEFT, DRIVER'S SIDE FOR TOURING AND GT CARS AND ON THE FACE ABOVE THE NUMBER FOR PROTOTYPES AND FORMULA CARS WHICH WILL ALLOW THEM TO ENTRY ON THE TRACK.

C) BOX

1) BOX RESERVATIONS

The box booking request must be made via the appropriate section on 'Circuit Enter' and by e-mail to [Ciro Sessa](mailto:Ciro.Sessa@acisport.it) no later than **Friday 30 August 2024**.

The Box assignment is made by ACI Sport (Ciro Sessa).

The box confirmation will arrive via email from the "Circuit Enter" portal with the request and payment methods.

The assignment of the box is subject to acceptance and signing of the regulations and conditions of use of the spaces..

2) COSTS

3) KEY PICKUP AND RETURN

The boxes will be available from 10.00 on Thursday 05th September 2024.

Delivery of the keys will be made as from 09.30 on Thursday 05th September 2024 at the gatehouse entrance Piazza Senna who will arrange for the relevant forms to be signed and collect a deposit of 100.00 euros as security for any damage.

The return of the keys must be made no later than 23.00., at the gatehouse at the Senna exit or to the attendant present in the paddock.

The deposit will be returned after checking the relative box.

4) SECURITY PROVISIONS WITHIN THE BOX:

- ✓ Smoking or the use of open flames is prohibited inside the boxes
- ✓ Inside the boxes it is forbidden to deposit flammable materials (gasoline, etc.), which should be stored outdoors;
- ✓ Leave fire hydrants, fire extinguishers and any other fire-fighting equipment visible and accessible;
- ✓ Ensure that emergency exits, transit areas and escape routes are fully accessible, avoiding any obstruction;
- ✓ Deposit waste oils in the appropriate containers located at different points inside the Circuit;
- ✓ **In case of accidental spills of flammable liquids, oils or substances that may make the pavements slippery, promptly remove and clean them.;**

5) BOX AND PIT CLEANING

- ✓ It is prohibited to leave tires inside and outside the box at the end of the event.
- ✓ It is forbidden to apply stickers of any kind to the pit floor.
- ✓ The boxes shall be sanitized daily by the occupants using cleaning chemicals.
- ✓ Before the keys are returned, they must be cleared of any material not present at the time of delivery
- ✓ At the end of the event, any tape placed on the floor from the pit lane must be removed to have a clean surface.
- ✓ A fine of 150,00 euro will be applied if the tape is not removed properly.

We remind you that there is a ban on the abandonment of special waste inside the Circuit.

Special waste (such as tires, carpeting, elastomers, batteries, brake discs, empty gasoline drums, brake pads, oil and air filters, spray cans, tnt rolls, wooden pallets) must be removed from the facility and disposed of at the Customer's expense. Any cost of restoration and disposal will be charged by Formula Imola S.p.A. to the responsible parties. Exhausted oils must be deposited in the appropriate containers located at various points within the paddock.

NOTHING ELSE, such as oil filters, MUST BE STORED in the containers for waste oil.

Normal waste must be recycled in the appropriate bins located outside the garages.

D) TIMETABLE OF THE EVENT

2) CIRCUIT ENTRANCE

Please strictly observe these times.

Transportation of materials and/or movement of heavy vehicles are not allowed during night hours unless specifically authorized by the Circuit Management.

During the weekend, access to the main paddock for loading and unloading of materials will only be allowed for a maximum duration of 45 minutes with the issuance of a delivery pass (subject to a cash deposit of 50.00 euros).

The entrance must take place strictly from Via Santerno – “Rivazza” gate entrance for people and vehicles, while from Piazza Senna the entrance will be exclusively pedestrian.

3) ADMINISTRATIVE CHECKS:

COMPETITORS AND DRIVERS WITH ITALIAN LICENSES.

ONLY AND EXCLUSIVELY the competitors/drivers who do not comply with the documentation uploaded on the portal with the registration or with documents that have expired in validity must present themselves.

COMPETITORS AND DRIVERS WITH LICENSES OTHER THAN ACI LICENSES WILL HAVE TO COMPULSORILY PRESENT THEMSELVES TO CARRY OUT THE SPORTING VERIFICATIONS (DOCUMENT CONTROL AND SIGNATURE VERIFICATION FORM)

The Administrative Checks will be held at the second Floor of Race Control Building (Office 1) as follows:

- from 09.00 to 11.00 on September 06th 2024 for all competitors and drivers with a license from another ASN and for ACI Sport license holders who are not in compliance with the documentation sent (declaration for minors, expired medical certificates, etc.).
- from 08.00 to 09.00 on September 07th 2024 EXCLUSIVELY FOR PARTICIPANTS IN THE ITALIAN HISTORIC CAR CHAMPIONSHIP for competitors and drivers with a license from another ASN and for ACI Sport license holders who are not in compliance with the documentation sent (declaration for minors, expired medical certificates, etc.).

4) TECHNICAL SCRUTINEERS:

As per regulations, **pre-race scrutineering will be conducted in attendance** at the Scrutineering Box or directly at the Team structures inside the paddock.

Please observe the following:

- **Clothing Declaration (DA): This must be uploaded to the 'Circuit Enter' portal, The declaration must be presented IN ORIGINAL during scrutineering.**

Competitors may use the equipment located in the scrutineering premises in compliance with current health regulations.

5) TEAM MANAGERS AND DRIVERS BRIEFING

Briefings will be held at the Briefing Room post on the first Floor of the Pit Control Building with access from staircase D.

6) TRACK WALK DRIVERS

The track walk for Drivers only and exclusively on foot (no bicycles or scooters "monopattini") with entrance next to the Race Control Building is scheduled at the following times::

- Thursday 05 September 2024 from 18.00 to 20.00

7) EXIT BILGES DISMANTLING STRUCTURES

We remind all participants that the dismantling of structures and the movement of vehicles may take place - for safety reasons - only at the end of the last scheduled race.

Any failure to comply with this provision will be reported to the Stewards for the measures provided for in the Regulations.

E) EVENT LOGISTIC

1) PASS DISTRIBUTION OF PASSES (WRISBANDS) FOR COMPETITORS AND SERVICES

Access to the Paddock is free so no "Paddock" passes (wrisbands) will be provided but only Service wrisbands (Pit Lane and Pit Wall, Media, Organization etc.).

The distribution of service passes (wrisbands) for Competitors will be carried out at second Floor of Race Control Building (Office 1) at the following times at the time of the delivery of the responsibility discharges for free practices at the following times from 15.00 to 19.00 of Thursday 05 September 2024, from 08.00 to 12.30 and from 14.00 to 18.00 of Friday 06 September 2024.

The distribution of service wrisbands for Services (Promoters, Tires men, Miscellaneous Services) will be made at second Floor of Race Control Building (Office 1) from 14.00 to 19.00 of Thursday 05 september 2024 from 08.30 to 12.30 and from 14.00 to 18.00 of Friday 06 September 2024.

2) ACCESS TO THE GRID

Access to the grid is allowed only to Pit-Wall pass holders.

3) ACCREDITATION CENTRE

The accreditation centre will be in **Via Lambertini, 8 – Imola - Bo** (attachment 6) and will observe the following hours::

- Saturday 07 September 2024 from 08.00 to 18.00

Team/clients may use the delivery service for a maximum of 10 envelopes, which must:

- Be closed;
- Carry the sender (team/client) name;
- Guest's name and surname;
- Name and number of a representative to be contacted in case of need;

For the collection of envelopes, it will be necessary to show an identification document.

4) TRANSPONDER DISTRIBUTION

Transponders must be collected at the timing room located on the first floor of the Pit Building between the Briefing Room and the Press Room (Track side) with access from staircase D at the following times:

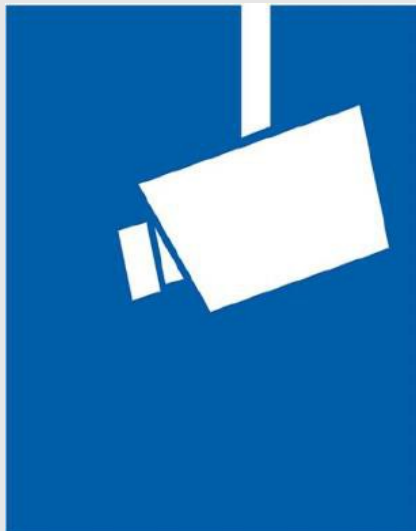
