To operationally facilitate the pre-race management of the various categories involved, Mr. Competitors / Drivers are strongly requested to scrupulously follow the current F.I.A. / A.C.I. sporting rules, as well as the provisions of this circular, regarding:

A) EVENT REGISTRATION

REGISTRATIONS FOR INDIVIDUAL SCHEDULED RACES

All entries must imperatively be received **within Monday September 15th 2024 at 12.00**, accompanied by the appropriate entry fees.

Registration must be made as follows:

Competitors with an Italian license:

1. **Compulsory** do the on-line "pre-registration" procedure on the ACI Sport website (Information on how to use this procedure can be found on the Aci Sport website)

Please note that pre-registrations, once taken in charge by the organizer will no longer be visible nor editable by the competitor.

N.B. A competitor with an Italian license may enter drivers with foreign licenses in the race.

The pre-registration even if accepted to be validated must be followed by sending the copy of the payment.

2. **Compulsory** register on the "[Circuit Enter](#)" Website.

C) PIT GARAGES

1) GARAGE RESERVATIONS

Garage reservation request must be made in the appropriate section through the "Circuit Enter" portal no later than **September 12th, 2024**. The box allocation will be made by ACI Sport and the confirmation will come through the email from the "Circuit Enter" portal with payment request.

Box reservations will not be considered unless at the same time as registration.

2) COSTS

The cost for the entire Weekend (Friday, Saturday, and Sunday) of each box is as follows:

3) PAYMENT

Payments may only be made in advance by Bank Transfer immediately after receipt of the confirmation of allocation to the same bank details as for the payment of entries above.

4) KEY PICKUP AND RETURN

Garages will be made available starting from 20.30 of 18/09/2024

Key delivery will be made at the main entrance of the circuit.

No deposit is required.

5) **SECURITY PROVISIONS WITHIN THE GARAGE:**

- ✓ Smoking or the use of open flames is prohibited inside the boxes
- ✓ Inside the boxes it is forbidden to deposit flammable materials (gasoline, etc.), which should be stored outdoors;
- ✓ Leave fire hydrants, fire extinguishers and any other fire-fighting equipment visible and accessible;
- ✓ Ensure that emergency exits, transit areas and escape routes are fully accessible, avoiding any obstruction;
- ✓ Deposit waste oils in the appropriate containers located at different points inside the Circuit;
- ✓ **In case of accidental spills of flammable liquids, oils or substances that may make the pavements slippery, promptly remove and clean them.;**

6) **GARAGE CLEANING**

We remind all participants that both paddocks and pits must be left free of tyres, which must be disposed of directly by the participants. In the event of non-compliance, the circuit management will charge the offenders for their disposal.

- ✓ **It is forbidden to leave tyres inside and outside the pits at the end of the event.**
- ✓ **It is forbidden to apply stickers of any kind on the pit floor.**
- ✓ **The pits must be sanitized daily by the occupants using chemical cleaning products.**
- ✓ **Before the keys are handed back, they must be cleared of any material does not present at the time of handing over.**
- ✓ **At the end of the event, any adhesive tape placed on the floor by the pit lane must be removed in order to have a clean surface.**

Entry to the circuit is allowed as follows:

- Friday 20 September from 08.00 to 20.00: Teams in the pdk

Please strictly observe these hours.

Transportation of materials and/or movement of heavy vehicles are not allowed during night hours unless specifically authorized by Circuit Management.

During the weekend, access to the main paddock for loading and unloading of materials will only be allowed for a maximum duration of 45 minutes with the issuance of a delivery pass (subject to a deposit of € 100.00).

3) **ADMINISTRATIVE CHECKS:**

COMPETITORS AND DRIVERS WITH ITALIAN LICENCES

ONLY AND EXCLUSIVELY competitors/driver who are not in good standings with the documents sent with the registration or with documents that have expired in validity must present themselves.

COMPETITORS AND DRIVERS WITH LICENSES OTHER THAN ACI ONES

WILL HAVE TO COMPULSORILY REGISTER TO THE "CIRCUIT ENTER" PLATFORM AND UPLOAD ALL THE REQUESTED DOCUMENTS TO ACCOMPLISH THE ADMINISTRATIVE CHECKS (DOCUMENT CONTROL)

The administrative checks will be held at the first floor of Race Control Tower according to the time reported in the event timetable.

4) **TECHNICAL SCRUTINEERING**

As per regulations, pre-race scrutineering will be conducted in attendance at the Scrutineering Garage or directly at the team's facilities. The forms required by the current regulations must be submitted at scrutineering in the prescribed places and manner. The forms can be downloaded [here](#).

The clothing declaration must be uploaded to the "Circuit Enter" portal and submitted in original during scrutineering.

5) **EXIT BILGES DIMANTLING STRICUTRES**

We would like to remind all participants that the dismantling of structures and the movement of vehicles may only take place - for safety reasons - at the end of the last scheduled race. Any failure to comply with this provision will be reported to the Stewards of the Meeting for the measures laid down in the Regulations.

1) WASTE DISPOSAL
