### 1. FOREWORD

The general rules apply as reported in the "Annuario ACI Sport 2022" and in each Motorsport Discipline Regulations and relevant updates, which become effective from their publication in the ACI SPORT official Website. This General Sanitary Protocol and each discipline's protocols included hereinafter complement the general rules and have the same binding effect.

This document aims at setting sanitary guidelines to ensure safety of all professionals involved in motor sport. It is based on recommendations issued by the FMSI (Federazione Medico Sportiva Italiana), medical consultant of the Italian National Olympic Committee - CONI. Sanitary guidelines are of the outmost importance, especially considering that the re-start of activities after the lockdown entailed increasing people moving around, to the extent that about 10% of infected people will likely get in touch with the remaining 90% who would presumably test negative for Covid-19. Such scenario shows how difficult it is to identify zero risk procedures and how important it is -beyond respect for applicable rules - everyone's awareness of safe personal behaviours to tackle the risk of infection.

Provisions included in this document will be updated as necessary, according to any future government regulations based on medical and scientific development and applicable to motor sport activities. This document aims to provide clear information and guidelines to those involved in such activities, in order to restart organizing track and road races safely.

This document is based on the guidelines issued by the Italian Presidency of the Council of Ministers - Department for sport on 4 May 2020. It identifies the sanitary protocol to tackle the diffusion of the SARS-CoV-2 Coronavirus. It also includes **specific protocols for each motorsport discipline** taking into account the key-principles hereinafter.

The above mentioned government guidelines have been updated by DPCM 11 June 2020, art.1 letter e), DPCM 7 May 2021 and 1 June 2021, Law Decree 221 of 24 December 2021, Law Decree 229 of 30 December 2021 and Law Decree 1 of 7 January 2022.

According to a risk analysis currently carried on by FMSI and the equivalent Sport Association in the U.S.A., motorsport —which is **an individual sport**- shows low Covid-19 diffusion risk rate, similarly to all other "**contactless sports**". Motorsport activities can therefore continue, provided protection measures for oneself and others are applied. Motorsport races, which take place outdoor, can be performed on tracks (autodromes or karting circuits) or on ordinary roads in case of disciplines such as rally, hill climb, ronde, slalom, off-road etc.

Competitions on circuits and roads take place in wide outdoor areas thus naturally ensuring social distancing among participants (drivers, car mechanics, track or road marshals, medical and



paramedical assistants, internal service staff). By way of example, any Italian circuits' paddock area and any national Rally's service park measure above 30,000 m<sup>2</sup>. Such general width, together with provisions to limit access to Teams' personnel only, allows for a very high person-to-space ratio, much wider than the one requested by social distancing regulations and medical-scientific recommendations. As a matter of fact, depending on the specific area someone is in, this ratio ensures 10m<sup>2</sup> up to 20m<sup>2</sup> space/person.

In order to restart motorsport activities and ensure the infection risk is under control, it is fundamental that **Personal Protection Equipment** items are used by all participants, compliance with the rules is monitored by appointed staff members and every participant is aware of the importance of his/her own respectful behaviour towards sanitary rules and other participants.

**Digitalisation** of some competition activities (drivers' briefing, administrative checking, Official Notice Board etc.) help to prevent people gatherings. Specific **Apps** developed for motorsport – provided they are privacy compliant- can also be used to track staff members up to 15 days following the event.

**An admission triage** before accessing the Reserved Area, as described hereinafter, allows to identify, keep on record and check participants and staff before and during the event.

#### 1.1. DEFINITIONS

**Sport Subject** is either an athlete or a staff member present at the event venue on the occasion of the event.

**Sport site** is any facilities intended to host sporting activities, either equipped with lavatories, toilets, showers or not, or any facilities consisting of one or multiple sporting areas of the same type or different types, having common spaces and auxiliary services, as identified by the relevant sporting authority.

**Reserved Area** is any operational areas intended for the organization of motorsport events and particularly:

- 1) Paddock Area (for circuits, karting circuits and short tracks)
- 2) Service park (for Rallies)
- 3) Other operational areas (for other disciplines such as Hill Climb, slalom, off-road etc.)

**Triage Area** is the first area where participants to the event are admitted and where the activities under article 4 are performed.

**Isolation Area** is the area where sport subjects showing Covid-19 symptoms during the event are isolated.



**Covid Manager** is the Organizer's appointed person in charge of coordinating infection control activities and reporting any symptomatic cases according to regional sanitary procedures.

**Sport Authority** is the Italian National Olympic Committee - CONI, the Italian Paralympics Committee, any National Sport Federation either Olympic and Paralympics.

**Sport Organizer** is any subject holding an Organizer licence issued by a National Sport Federation; any consortia (associations and companies established according to article 90 of Law 289/2002 and its successive amendments and corrigenda, and registered into the National Registry established according to article 5, paragraph 2, letter c) of the D.Lgs. 242/1999 and its successive amendments and corrigenda; companies established according to the criteria described in Law 91/1981; sport groups mentioned at article 6 of Law n. 78/2000).

### 2. PERSONAL PROTECTION EQUIPMENT

Below are described different PPE items together with relevant information on their functions and limits.

#### 2.1. TYPES OF FACE MASKS

### FFP3

- Filters 98-99% of particles ≥ 0.6 μm
- If equipped with exhalation valve, does not prevent the transfer of respiratory droplets to others (the exhalation valve is solely for the wearer's comfort)
- Must be worn by medical/sanitary personnel assisting infected and possibly infected persons, especially during operations which cause higher aerosol emissions (e.g. intubation, bronchoalveolar continuous wall suction, bronchoscopy)

#### 2.2 FUNCTIONS OF FACE MASKS

**FFP1:** This type of masks are suitable in work environments where normally there is NOT exposure to any toxic or fibrogenic powders or aerosols. This type of masks **filter at least 80%** of airborne particles of **diameter up to 0,6 \mum** and can be used provided the occupational exposure limit value is not exceeded by more than 4 times.

In construction and food industries FFP1 masks are usually sufficient. They protect from non-toxic and non-fribrogenic dust. **Total leakage can amount to maximum 25% to the inside.** 

**FFP2:** This type of masks are suitable in work environments where breathable air contains **substances harmful** to health and possibly causing genetic alterations. This type of masks **filter at least 94% of particles up to \geq 0.6~\mu m** present in the air and can be used until the concentration of hazardous particles in the air reaches maximum 10 times the occupational exposure limit value. FFP2 masks are used for workers exposed to **aerosols**, vapours and fumes causing respiratory diseases in the long term, like lung cancer, or massively increasing the risk to develop secondary diseases, like active tuberculosis.

**FFP3**: This type of face masks filter bacteria and are suitable for healthcare professionals (FFP3 NR). These are disposable three-flap masks with covered exhalation valve (standard reference: EN 149:2001+A1:2009) and EN14683:2005 Type II R classification, including protection against splashes and fluids and efficiency of bacterial filtration (**bacterial filtration > 98%**; breathing resistance ≤ 5mm H2O/ cm2; splash resistance > 120 mm/Hg).

FFP3 face masks ensure the **highest protection** from pollutants in breathable air, with a **maximum leakage of 5% to the inside and a minimum filtration of 99% of particles up to 0,6 \mum. They also filter toxic, carcinogenic and radioactive particles. These masks can be used in work environments in which the occupational exposure limit value is exceeded up to 30 times.** 

### In short:

1. FFP2 and FFP3 protect from viruses, unlike FFP1s



- 2. efficiency of bacterial filtration is ruled in EN149 CEE standard
- 3. DISPOSABLE face masks are labelled "NR"
- 4. REUSABLE face masks are labelled "R"
- 5. Usage duration of face masks is variable and it is specified by the producer
- 6. The abbreviation FFP stands for "Filtering-face-piece"

As a reminder, according to the WHO International Guidelines, <u>exclusively</u> protective face masks FFP2 and FFP3 MUST be used by healthcare personnel.

### Other types of face masks

Any other face masks on the market is neither a medical device nor a PPE. They can be produced according to article 16, paragraph 2, D.L. 18/2020 and producers are liable for their safety (by way of example producers must guarantee that the materials used are not known as agents irritating the respiratory tract or causing any other harmful health effect, that they are not easily flammable etc). No assessment by Istituto Superiore di Sanità and INAIL is required for this kind of masks. Such masks cannot be used in hospital or healthcare environments as they do not comply with the technical requirements set for medical devices and PPEs.

Wearing such masks does not prevent from respecting social distancing and all other applicable provisions against the Covid-19 pandemic.

### 2.3 GOGGLES AND FACE SHIELDS

Protective goggles are as important to prevent virus transmission as respirators. By the way, Covid-19 was first discovered in Wuhan by an optician who had noticed an atypical form of conjunctivitis, as an effect of virus infection. It is therefore recommended to use eye protection items available on the market. Traditional safety goggles -such as those in the picture- are suitable for people already wearing corrective glasses, as they can be worn on top.

Full face protective shields in polycarbonate can effectively replace protective goggles, even if they are mostly used in medical environment. In particular, face shields can be used alongside face masks FPP1 or FPP2 to safely transfer an injured driver into the rescue vehicle and possibly assist him/her in the Autodrome Medical Centre.







### 2.4 PROTECTIVE GLOVES

Protective gloves are usually made of nitrile rubber, natural rubber latex or can be latex-free for allergic people. Basically, gloves can be sterile or non-sterile. The first ones are used for operations requiring sterilized conditions while the latter can be used to check medical conditions of the injured and move him/her in rescue operations. In any case, to improve protective effectiveness for oneself and the others, it is recommended to use the "double gloving" technique, that is wearing double non-sterile gloves -or a sterile glove on a non-sterile one- in both hands.



### 3. ANTIBODY (SEROLOGY) TESTS

Current information on the limits of available tests would suggest to refrain from taking conclusions. However, in order to give the appropriate instructions it is necessary to briefly clarify the matter.

Despite the possible lack of accuracy of antibody tests, motorsport cannot rely on diagnostic tests only, as they require longer time and are currently prescribed only to people already tested positive for Covid-19 and often hospitalized.

Furthermore, in spite of the pros-and-cons of antibody tests, only an "immunity proof" would guarantee entire safety. Unfortunately, it is not currently available any test certifying one's immunity to the virus, first of all because it is not clear whether antibodies produced in response to the infection provide total or partial protection.



In this context, it might be useful to use an App, such as the one adopted in 2018 on the occasion of the Rally di Roma Capitale, tracking registrants until the following 15 days, that is the maximum virus incubation period.

### 4. SANITARY PROTOCOL FOR RACES ON TRACK AND ON ROAD

As mentioned above, motorsport is an individual sport without physical contact with other participants and takes place in wide outdoor areas such as autodromes or karting circuits and in enclosed areas when competitions are held on ordinary roads ("Reserved Areas").

By way of example, the Monza circuit's paddock area measures about 40,000 m<sup>2</sup> and Vallelunga's one about 37,000 m<sup>2</sup>. Such extensions allow much wider social distancing than what is required by law.

People sharing these spaces include drivers, car mechanics and engineers form drivers' teams, race officials, Organizer's staff etc. ("the Participants").

Another important element in the fight against Covid-19 is drivers' clothing. Drivers wear flame-resistant suits, full-face helmet and a fireproof balaclava underneath it, fireproof gloves (the latter not mandatory for co-drivers).

Additionally, in order to ensure social distancing and prevent gatherings, the following measures have been adopted:

- 1) Reduction of team/service staff members admitted in the event spaces, so as to allow maximum social distancing.
- 2) Digitisation or minimization of activities entailing possible gathering of participants (checkings, set-up, parc fermé, drivers' briefing, prize giving ceremony etc.).
- 3) Since 1<sup>st</sup> June 2021 (1<sup>st</sup> July for indoor events) in the so-called White and Yellow Zones only, competitions and federal events are open to the public, and since 6th August 2021 the access is possible only to **Green Pass** holders having booked pre-assigned seats, provided at least 1 metre distance between spectators (except for family members) and between staff members. Venues' capacity is permitted as follows: in White Zones, up to 50% of the maximum authorized capacity if the event takes place outdoor and 25% for indoor events; in Yellow Zones, up to 25% of the maximum authorized capacity but, in any case, not above 2,500 spectators in outdoor facilities and 1,000 in indoor facilities. For major events of national or international relevance, depending on the epidemiologic development, capacity limits can be modified by the Under-Secretary of State for Sport, upon advice of the Ministry of Health.
- 4) In competitions on roads, the Organizer shall invite participants to respect social distancing and applicable sanitary protocols.

Building on the actions above, further measures have been taken to ensure that competitions on track and on road can take place.



### 4bis DIGITAL GREEN CERTIFICATE (so called GREEN PASS) TO ACCESS MOTORPSORT COMPETITIONS AND TEST AREAS

With reference to the entry into force of Law Decrees n. 221 of 24 December 2021, n. 229 of 30 December 2021, n. 1 of 7 January 2022, the following tables recap the rules for accessing motorsport competitions and test areas:

N.B.: Law Decree n. 1 dated 7 January 2022 introduces the vaccination requirement for people over 50 years, and in art. 1 it incorporates Law Decree n. 44 dated 1 April 2021 (converted, with modifications, under Law n. 76 dated 28 May 2021) adding the art. 4-quinquies (Extension of the use of vaccination and recovery certificates in the workplace). Consequently, since 15<sup>th</sup> February 2022 and until further notice, people over 50 years being required to be vaccinated and carrying out a private work activity, in order to access the places related to their work activity, must have and exhibit one of the COVID green certificates of vaccination or recovery (the so-called Super Green Pass), according to the article 9, paragraph 2, letters a), b) and c-bis) of Law Decree n. 52/2021.

Since 10<sup>th</sup> January 2022 access to Reserved Areas can be obtained only by holders of the Green Pass (see tables above) who must show it, either in digital or paper format, at the Accreditation Centre (see next paragraph). Such measure does not apply to children under the age of 12 and in case of proof of medical exemption from vaccination.

Given the ongoing pandemic and the extension of the state of emergency until 31<sup>st</sup> March 2022, the Organizer –in his role as responsible person for the sporting event- must include in the Sanitary Emergency Plan adequate provisions stating that the Green Pass (issued according to applicable laws) is mandatory to participate in the event in whatever role (competitor, race official etc.). Such obligation must be made known by the Organizer since the opening of registrations.

To verify the validity and authenticity of COVID-19 Super Green Pass Certificates held by participants in digital or paper format, Organizers must download the App "VerificaC19" issued by the Ministry of Health, which must be used only by the Organizers' operators in charge of the Green Certificates' control during the event.

a) The Organizer shall establish a Accreditation Centre located ahead of the Reserved Area's entrance.



The Accreditation Centre can be accessed only by the contact person of each participant (Competitor/Service).

To access the Accreditation Centre it is necessary to hold a Green Pass -either in digital or paper format- and contact persons must hold paper QR codes of their participants.

The Organizer shall give instructions to ensure that social distancing is maintained at the Accreditation Centre and shall place hand sanitizer dispensers supplying hydro alcoholic disinfectant solutions.

Anybody accessing the Accreditation Centre must sanitize his/her hands and wear a face covering.

In the Accreditation Centre the Organizer's staff shall:

- (i) Identify the contact person of participants (Competitor/Service);
- (ii) verify the validity and authenticity of COVID-19 Green Pass held by participants in digital or paper format, through the App "VerificaC19";
- (iii) hand over the event passes (wristbands);
- (iv) hand over the materials needed for the competition;
- (v) measure visitors' body temperature;
- b) At the entrance of each Reserved Area ad hoc facilities ("Triage Area") must be set up where each Participant -in the presence of Organizer's staff adequately equipped with PPEs- shall:
  - (i) sanitize his/her hands at the hydro alcoholic solution dispensers provided by the Organizer;
  - (ii) wear a surgical face mask, which must be provided by the Organizer in case the accessing person does not have one;
  - (iii) respect at least 1 metre physical distance with the others;
  - (iv) be identified through control of the passes (for team/service members) previously withdrawn at the Accreditation Centre;
  - (v) have his/her body temperature measured;
- c) In case someone's body temperature is 37.5° Celsius or higher, the following actions are taken (the incident being referred to as "the Suspect Case"):
  - (i) the relevant participant is inhibited to access the proper Reserved Area;
  - (ii) the relevant participant is isolated in an "Isolation Area" detached from the Triage Area;
  - (iii) information about such symptomatic case is given to the Covid Manager who must start the regional sanitary procedure;
  - (iv) the relevant participant shall provide the Covid Manager with the names of the other Participants s/he has been in touch ("the Other Suspect Cases");



- d) Unless what listed under point c) above occurs, Participants wearing adequate PPEs in line with sanitary rules for the duration of the whole event, are handed a leaflet containing fundamental recommendations to reduce the spreading of the Coronavirus ("Covid Kit"). They are subsequently admitted to the Reserved Area.
- e) In the Triage Area and in the Reserved Area Participants must always:
  - (i) wear face covering as required by applicable sanitary regulations;
  - (ii) maintain at least 1 metre physical distance from the others;
  - (iii) frequently wash their hands with water and soap or sanitize them;
  - (iv) avoid touching their mouth, nose and eyes;
  - (v) make use of the hand sanitizer dispensers made available by the Organizer in the Reserved Area.

### 5. ADDITIONAL ORGANIZATION MEASURES

### 5.1 Race Officials and Stewards

All Race Officials attending the event must respect the provisions of article 4 above.

The Organizer shall provide them with face coverings, in case they have none.

Areas available for use to Stewards and Scrutineers must be sanitized according to the instructions in paragraph 5.2.

### 5.2 Cleaning and sanitising of spaces during the event

The Organizer shall ensure daily cleaning and necessary sanitising of technical areas, facilities, workstations and common areas. In case someone tested positive for Covid-19 has been in any such spaces, cleaning and sanitising will be carried out according to the instructions of the circular letter 5443 of the Ministry of Health of 22<sup>nd</sup> February 2020 and the relevant rooms will be adequately ventilated.

Daily, at the end of business hours, cleaning and sanitising with appropriate detergents shall be performed in offices and common spaces on keyboards, touch screens, mouse devices.

### 5.3 Food and Beverage

Supply of Food and Beverage is permitted in line with relevant applicable laws and sanitary regulations.

### 5.4 Sanitising of Cars and Technical Assistance Areas

Each Team shall ensure daily sanitising of their racing cars and technical assistance areas with appropriate chemical detergents.



### 5.5 Management of a symptomatic case

In case any Sport Subject during the event develops symptoms such as fever, respiratory infections, cough, sore throat, conjunctivitis, diarrhoea, loss of taste or smell, s/he must immediately report it to the Covid Manager and be isolated in the Isolation Area. Isolation in rooms previously identified by the Organizer in cooperation with the Chief Medical Officer must be arranged also for any other person who has had close contact with the symptomatic person.

The regional sanitary procedure for symptomatic cases shall be started immediately.

### 5.6 Vigilance

The Organizer shall appoint a Covid Manager.

The Covid Manager monitors that these guidelines and the relevant safety measures are correctly applied during the event, also seeking cooperation by specific officers identified in each discipline's protocols.

Any offence shall be reported by the Covid Manager to the Stewards who can apply penalties up to the exclusion from the event.

10	Service park (Reserved Area)	Service park access shall be exclusively restricted to the sport personnel with passes. It shall be located in an enclosed area, whose entrance and exit, duly separated from each other, can be easily controlled. The Organizer will raise participants' awareness about the need to keep social distancing and to comply with current sanitary regulations. The park shall be of a suitable size to house Teams' facilities being distant at least one meter from each other, in compliance with social distancing.
